Additional information:

Acids: When mixing acids with water (diluting), caution must be taken as heat will be generated which causes violent spattering. Always add a small volume of acid to a large volume of water, NEVER the reverse.

Respirators: In general the use of respirators should be limited and engineering controls employed to avoid exposure.
