### SECTION 4: First aid measures

#### Description of first aid measures

##### General information

Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel. Chemical burns must be treated by a physician.

##### Inhalation

Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. #### **Extinguishing media**

#### **Advice for firefighters**

#### Personal precautions, protective equipment and emergency procedures

#### Eye/face protection

#### Hand protection
