## **SECTION 4: First aid measures**

### **Description of first aid measures**

**General information** Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

**Inhalation** Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Loosen tight clothing such as collar, tie or belt. Get medical attention if symptoms are severe or persist.

### **Extinguishing media**
